- 4. **COMPENSATION:** Broker shall be compensated by the seller or the listing broker.

- CONFLICT OF INTEREST (PURCHASERS): Client acknowledges that Broker may represent other clients or customers desirous of 6. purchasing property similar to the desired property. Client acknowledges and agrees that Broker may show more than one client or customer the same property, and may prepare offers on the same property for more than one client or customer.
- CONFLICT OF INTEREST (SELLERS): In the event Client elects to make a bona fide offer on real property listed by Broker, Broker 7. shall act as disclosed dual agent of both Client and the owner of the real property listed by Broker pursuant to a written agreement between Broker, Client and the owner of the listed real property.
- NON-DISCRIMINATION: It is agreed by Broker and Client, parties to this Agreement, that as required by law, discrimination because 8. of religion, race, color, national origin, age, sex, disability, familial status, marital status, height or weight by said parties in respect to the purchase of the desired property is prohibited.
