UNLICENSED ASSISTANT APPLICATION FOR MLS ACCESS

Unlicensed Assistants shall be individuals who do not hold a Real Estate license granted by the State of Michigan. Such individuals may hold a limited membership in the Association without voting rights or other obligations of full membership, but shall be eligible to purchase view only and data entry access into ECAR MLS data and adhere to all rules and regulations as determined by the Board of Directors. At no time shall an Unlicensed Assistant enter a listing in his/her name. All such Unlicensed Assistants of any office, firm company, partnership or corporation must be affiliated with an MLS participant with ECAR MLS to be eligible for access.

Unlicensed Assistant shall not use the terms REALTOR® or REALTORS®, nor the imprint of the emblem seal of the NATIONAL ASSOCIATION OF REALTORS®.
